#### **Civic Responsibility**

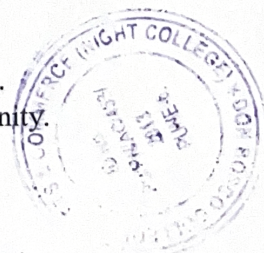
1. Engage in behaviors that reflect positively on the college community.
